

# Grand Slam Application

All catches, past and present are eligible as long as they have been caught during a single calendar day and have been caught in accordance with IGFA rules. For purposes of the IGFA Grand Slam Clubs, catching three species in one day equals a **Grand Slam**, four different species equals a **Super Grand Slam**, and five different species equals a **Fantasy Slam**.

**It is not necessary to kill the fish and IGFA encourages catch-and-release.**

Photos of the angler with the fish and the contact information of the captain and/or witness are required for catches made after January 1, 2012. Send complete application and photos to IGFA at 300 Gulf Stream Way, Dania Beach, FL 33004.
